DONECK EUROFLEX S.A. is a medium-sized and globally active manufacturer of flexographic and gravure printing inks, active right across Europe. It currently employs approx. 160 staff at its headquarters in Grevenmacher, Luxembourg.

The company produces **solvent-based and water-based flexographic and gravure printing inks** which are primarily used to refine paper and foil packaging. It services various market sectors. The products' main areas of application are printing inks for flexible packaging, paper bags & wrapping paper, as well as cardboard boxes and napkins. This often also includes food packaging/items of daily use.

With its aim of ensuring high-quality customer and delivery service worldwide, DONECK EU-ROFLEX S.A. has in recent years built up the **DONECK NETWORK**, consisting of eight branches in in Chile, Germany, Great Britain, Italy, Poland, Spain, Hungary and the USA. These companies collectively employ another 60 staff, and are responsible for local sales, technical customer service, some customised colour mixing, and distribution/logistics. The DONECK NETWORK supplies to over 60 countries.

The worldwide customer base includes packaging manufacturers of various sizes. The spectrum ranges from small owner-managed companies to larger medium-sized enterprises and international packaging groups.

DONECK EUROFLEX S.A.'s history dates back to 1977, when Hans-Gerd Doneck took the plunge into self-employment after gaining many years of professional experience in Pluwig, Germany. Mr Doneck sold the company to the family of its present-day owners in 1991. Arndt Breitbach, who significantly built up the business from 1991 onwards, particularly from 1998 onwards, and provided important stimulation for growth, is today the majority owner. Since 2011, he has been supported in his role of managing partner by the second Managing Director for Sales, Edgar Becker, who has also been with the company for many years. The constant growth saw a modern printing ink factory established in Grevenmacher, Luxembourg in 1998. The ever increasing sales meant expansion was soon necessary: a production plant for environmentally friendly water-based inks was added onto the existing building in 2003, providing space for production, as well as new warehousing, shipping and laboratory facilities. This is where the entire first stage of production takes place, and a large part of all products distributed by the DONECK NETWORK are manufactured.



With its know-how, flexibility, dedicated and competent staff, and state-of-the-art production equipment, the company ensures high quality in its products and services. This includes:

It is based on the aim of permanent and continuous improvement in all areas. DONECK EUROFLEX S.A. has already had a quality management system certified to ISO 9001 since 2001.
